Auction announcement Reopening of five-year Federal notes (Bundesobligationen – “Bobl”) series 189 by auction

As already announced in the issue calendar for the second quarter of 2024, the Federal Government will reopen once again the

2.10 % five-year Federal notes series 189 of 2024 (2029)

on 21 May 2024, using an auction procedure. An increase of € 4 billion is envisaged for the issue (auction allotment and retention quote). The current volume of this series amounts to € 17 billion. Members of the Bund Issues Auction Group are entitled to bid.
