



Information on the Securities Lending in the “Asset Purchase Programme” (APP)

Deutsche Bundesbank has made its holdings of securities purchased under the “Public Sector Purchase Programme” (PSPP) and “Corporate Sector Purchase Programme” (CSPP) available for securities lending.

Since April 2015 Deutsche Bundesbank participates in “Automated Securities Lending” (ASL), which enables borrowers to avoid settlement failures (fails-lending). Since 5 October 2015 Bundesbank’s PSPP holdings are also available for lending via Clearstream’s strategic lending facility “Automated Securities Lending Plus” (ASLplus). **Since 18 July 2016 CSPP holdings are also available via this channel.**

In ASLplus, market participants are able to borrow securities out of Bundesbank’s PSPP and CSPP holdings at a minimum spread over the prevailing rate for General Collateral (GC). Bundesbank’s PSPP and CSPP holdings are available for lending via ASLplus on a cash neutral basis. The maximum term for a securities lending transaction in ASLplus is 35 days.

Market participants looking to borrow bonds via ASLplus out of Bundesbank’s PSPP and CSPP holdings are requested to contact Clearstream Banking¹ in order to make the arrangements necessary for a participation in this facility.

In addition to Clearstream Banking’s securities lending facilities, Deutsche Bundesbank is preparing a facility for bilateral transactions for PSPP holdings which combine repo and reverse repo transactions. Details will be published here as soon as possible.
