### **Ranking list of the Bund Issues Auction Group**

In the first half of 2026, Federal securities (Federal bonds, Federal notes, Federal Treasury notes, Treasury discount paper and Green Federal securities) were issued in 62 auctions via the Bund Issues Auction Group.

The following list shows the latest ranking of the 33 group members. The ranking is based on the allotted amounts in the first half of 2026, weighted by the respective duration and interest rate risk of the auctioned securities. The relevant weights were announced 10 December 2020, applicable since January 2021.

The ranking will be published twice a year, in June and December.
