Shows analyses of historical allotment results






#### Published ranking lists

Displays the most recently published semi-annual and annual ranking list

Displays current allotment results, ranking position and position in current auction

### Entering and deleting bids

#### General information

- Submission of price bids and non-competitive bids; yield bids only for Bubills
- Restricted to a maximum of 30 bid fields (including deleted bids)
- Multiple bids (identical price/yield and amount) permissible with warning message
- Separate display of bidding rules possible

#### Displaying bids:



<input type="text" value="100"/>		Bids not yet sent
<input type="text" value="100"/>	Confirmed	Bids accepted by system
<input type="text" value="100"/>	Confirmed	Bids accepted by system with warning message
<input type="text" value="9,999,999"/>	Maximum bid amount exceeded.	Example of impermissible entry

#### Entering bids

- Enter amounts in € million, then click the “Send bids” button or press enter
- “Non-competitive bids”: check the “Non-competitive” checkbox

#### Changing and deleting bids

- Bid not yet sent: overwrite or delete entry
- Sent bid: change the price/yield using the arrow symbols simultaneously:

Change price - All bids submitted  

- Change bidding volume by overwriting the amount or delete the bid by checking the “Delete” checkbox and clicking on the “Send bid” button or press enter
- Successfully deleted bids can be found in the logging data

#### Assigning user roles

- Role of “bidder”: all functions without analysis of auctions
- Role of “analyst”: sees auction announcement and invitation to bid; analyses auctions
- Role of “auditor”: sees auction announcement, invitation to bid and bids; analyses auctions and logging data
- Role of “user manager”: sees BBS users with their assigned roles
