List of coin validation devices

Alongside coin processing and coin acceptance devices for professional use by parties subject to Regulation (EU) No 1210/2010 and section 36 of the Bundesbank Act, the Deutsche Bundesbank also tests – at the request of the manufacturer – coin validators, coin modules, cash-recycling-machines (CRM/retail) and customer-operated deposit devices (type 1, retail) designed for other purposes.

The test results are valid for two years from the issue date (test date).

Important:

The coin validators, coin modules and customer-operated deposit devices (type 1, retail) listed here are not subject to Regulation (EC) No 1338/2001 or Regulation (EU) No 1210/2010. They were tested at the request of the manufacturer. The devices put forward by the manufacturers were assessed only in terms of whether they were able to reliably detect the counterfeit euro coins most frequently removed from circulation at the time of testing. Please note that this publication does not constitute a purchase recommendation on the part of the Bundesbank.
