

## Announcement Reopening of Federal Treasury notes

As already announced in the issuance calendar for the first quarter of 2011, the Federal Government will reopen the

**1.50 % Federal Treasury notes of 2011 (2013)**  
issued on 23 February 2011 - ISIN DE0001137339 // SIN 113 733

by auction on 16 March 2011. An increase of €6 billion is envisaged for the issue (auction allotment and amount set aside for secondary market operations). The current volume amounts to €7 billion. Members of the Bund Issues Auction Group are entitled to bid.
