

Auction announcement Treasury discount paper (Unverzinsliche Schatzanweisungen – “Bubills”) of the Federal Republic of Germany

As already announced in the issuance calendar for the fourth quarter of 2011, the Federal Government will issue Treasury discount paper (“Bubills”) with a maturity of 6 months for sale by auction on 5 December 2011. An issue volume (auction allotment and amount set aside for secondary market operations) of € 3 billion is envisaged. Members of the Bund Issues Auction Group are entitled to bid.

Time schedule of the auction procedure:

Date of invitation to bid: Friday, 2 December 2011

Bidding period: Monday, 5 December 2011, from 8.00 a. m. until 11.00 a. m. Frankfurt time

Value date: Wednesday, 7 December 2011
