Announcement of auction Reopening of 10-year Federal bonds

As already announced in the issuance calendar for the third quarter of 2013, the Federal Government will reopen once again the

1.50 % bonds of the Federal Republic of Germany of 2013 second issue (2023)
issued on 22 May 2013 - ISIN DE0001102317 // SIN 110 231

on 14 August 2013, using an auction procedure. An increase of €4 billion is envisaged for the issue (auction allotment and amount set aside for secondary market operations). The current volume of the bond amounts to €14 billion. Members of the Bund Issues Auction Group are entitled to bid.

Interest payment: 15 May annually,
interest has begun to accrue on 15 May 2013
