Announcement Reopening of Federal Treasury notes

As already announced in the issuance calendar for the third quarter of 2013, the Federal Government will reopen the

0.25 % Federal Treasury notes of 2013 second issue (2015)
issued on 21 August 2013 - ISIN DE0001137438 // SIN 113 743

by auction on 18 September 2013. An increase of €5 billion is envisaged for the issue (auction allotment and amount set aside for secondary market operations). The current volume amounts to €5 billion. Members of the Bund Issues Auction Group are entitled to bid.
