Announcement of auction Reopening of 10-year Federal bonds

As already announced in the issuance calendar for the second quarter of 2014, the Federal Government will reopen once again the

1.75 % bonds of the Federal Republic of Germany of 2014 (2024)
issued on 29 January 2014 - ISIN DE0001102333 // SIN 110 233

on 16 April 2014, using an auction procedure. An increase of €4 billion is envisaged for the issue (auction allotment and amount set aside for secondary market operations). The current volume of the bond amounts to €14 billion. Members of the Bund Issues Auction Group are entitled to bid.

Maturity: 15 February 2024
Interest payment: 15 February annually,
interest has begun to accrue on 31 January 2014
First interest payment: 15 February 2015 for 380 days
