# Announcement of auction Reopening of 10-year Federal bonds

As already announced in the issuance calendar for the fourth quarter of 2014, the Federal Government will reopen the

### **1 % bonds of the Federal Republic of Germany of 2014 (2024)**

issued on 10 September 2014 - ISIN DE0001102366 // SIN 110 236

on 1 October 2014, using an auction procedure. An increase of €5 billion is envisaged for the issue (auction allotment and amount set aside for secondary market operations). The current volume of the bond amounts to €5 billion. Members of the Bund Issues Auction Group are entitled to bid.

Interest payment: 15 August annually,
