Announcement of auction Reopening 10-year Federal bond

As already announced in the issuance calendar for the second quarter of 2016, the Federal Government will reopen once again the

0.50 % bond of the Federal Republic of Germany of 2016 (2026)
issued on 13 January 2016 - ISIN DE0001102390

on 20 April 2016, using an auction procedure. An increase of €4 billion is envisaged for the issue (auction allotment and amount set aside for secondary market operations). The current volume of the bond amounts to €14 billion. Members of the Bund Issues Auction Group are entitled to bid.

Maturity: 15 February 2026
Interest payment: 15 February annually,
interest has begun to accrue on 15 January 2016
First interest payment: 15 February 2017 for 397 days
