# 1 Dataset description

## 1.1 Overview and identification

**Dataset abstract:**

The Zentralkartei Banken (ZentK) is the database where the master data for the institutes with reporting obligations (MFIs, their foreign branches and subsidiaries as well as the multi-office banks) are administered chronologically and therefore their codification in all surveys of the banking statistics. This key information is used uniformly from all units of the banking statistics. Due to the high confidentiality of the data the access for researchers is restricted to a subset of the variables and some of them are provided in less detail than the underlying data.

On the other side, given the information available the creation of additional variables proved to be helpful. Thus, this version includes a variable created by the RDSC that informs whether an institute has acquired or merged with another institute. Sometimes, researchers additionally need to know the identifiers of the institutes involved in a merger or acquisition. ZentK offers only information of acquisitions by institute of the same type. To capture the acquisition of a purely domestic institute by an institute with legally dependent branches abroad (multi-office bank) there is need of an additional variable that is provided in this dataset.

### 1.4 Aggregation method

---

For yearly or quarterly use data from the monthly master data has to be delivered in a suitable fashion. One month has to be selected and the others have to be deleted. Either the most frequent value or the last value may be taken as yearly (quarterly) value if master data changes within a year (quarter). We provide the last value. If a year (quarter) is not complete in the sense that at least the last month is missing, all observations of the incomplete year (quarter) have to be dropped.

For transforming the monthly master data into yearly or quarterly data STATA-code is available.
