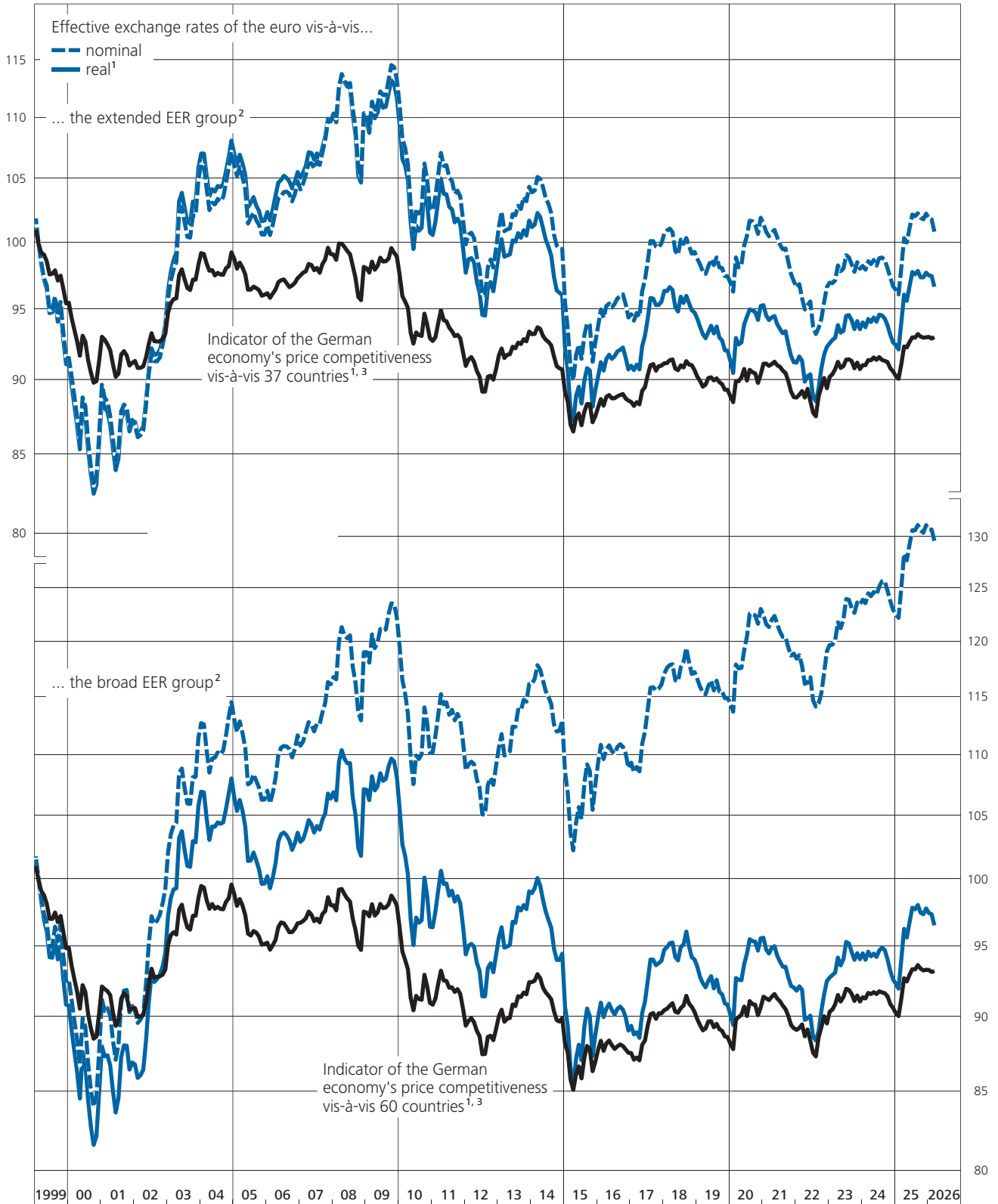


### III. Effective exchange rates
