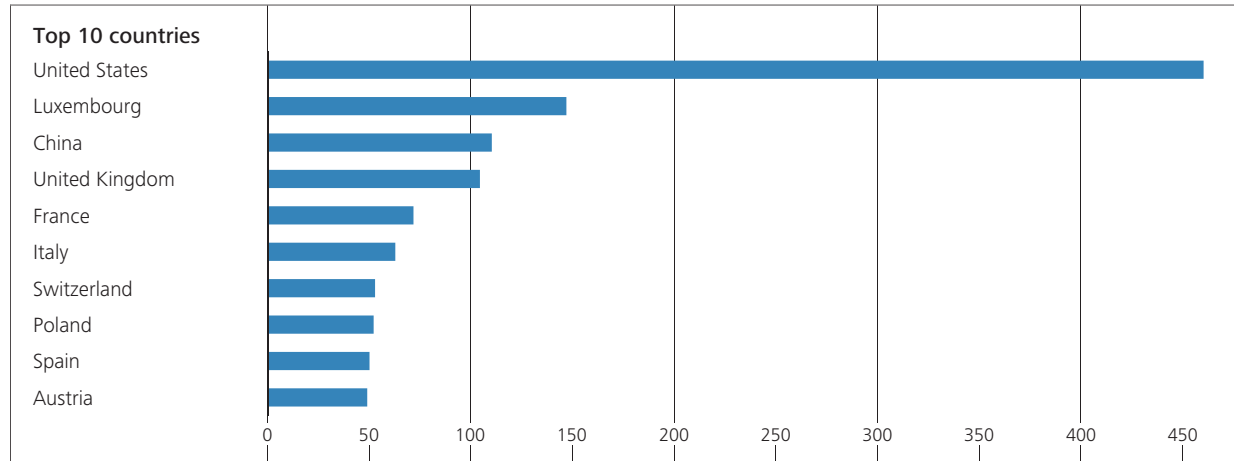

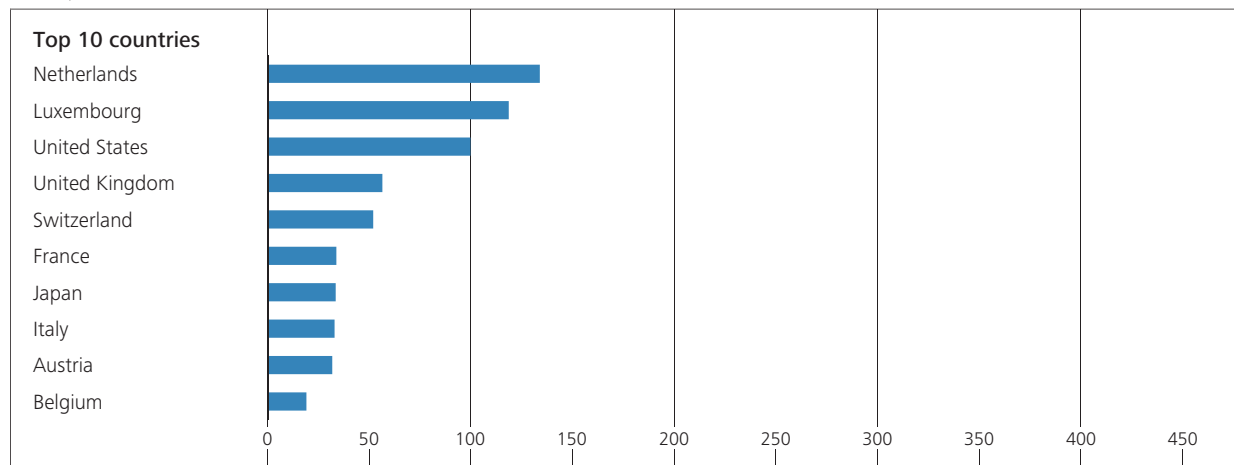

2. Foreign direct investment in the reporting country by immediate investing economy (IIE) & ultimate resident sector/activity (URSA)

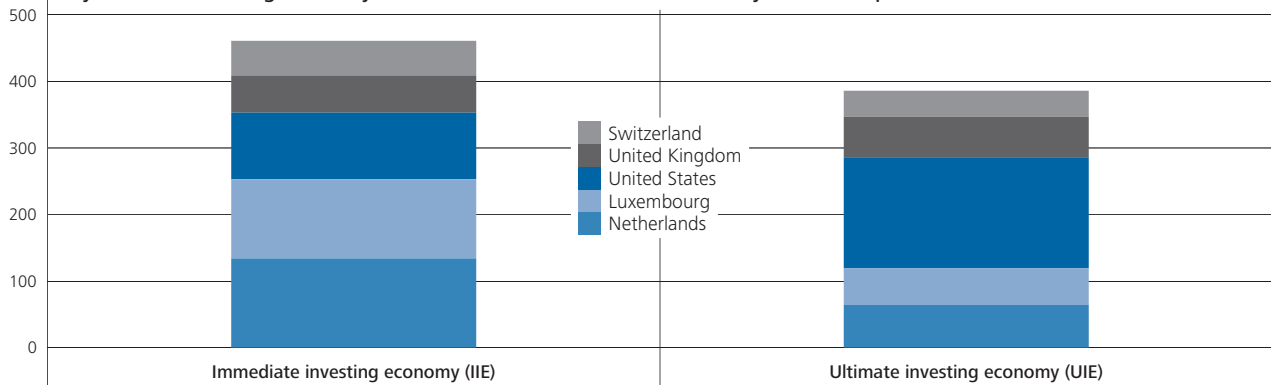

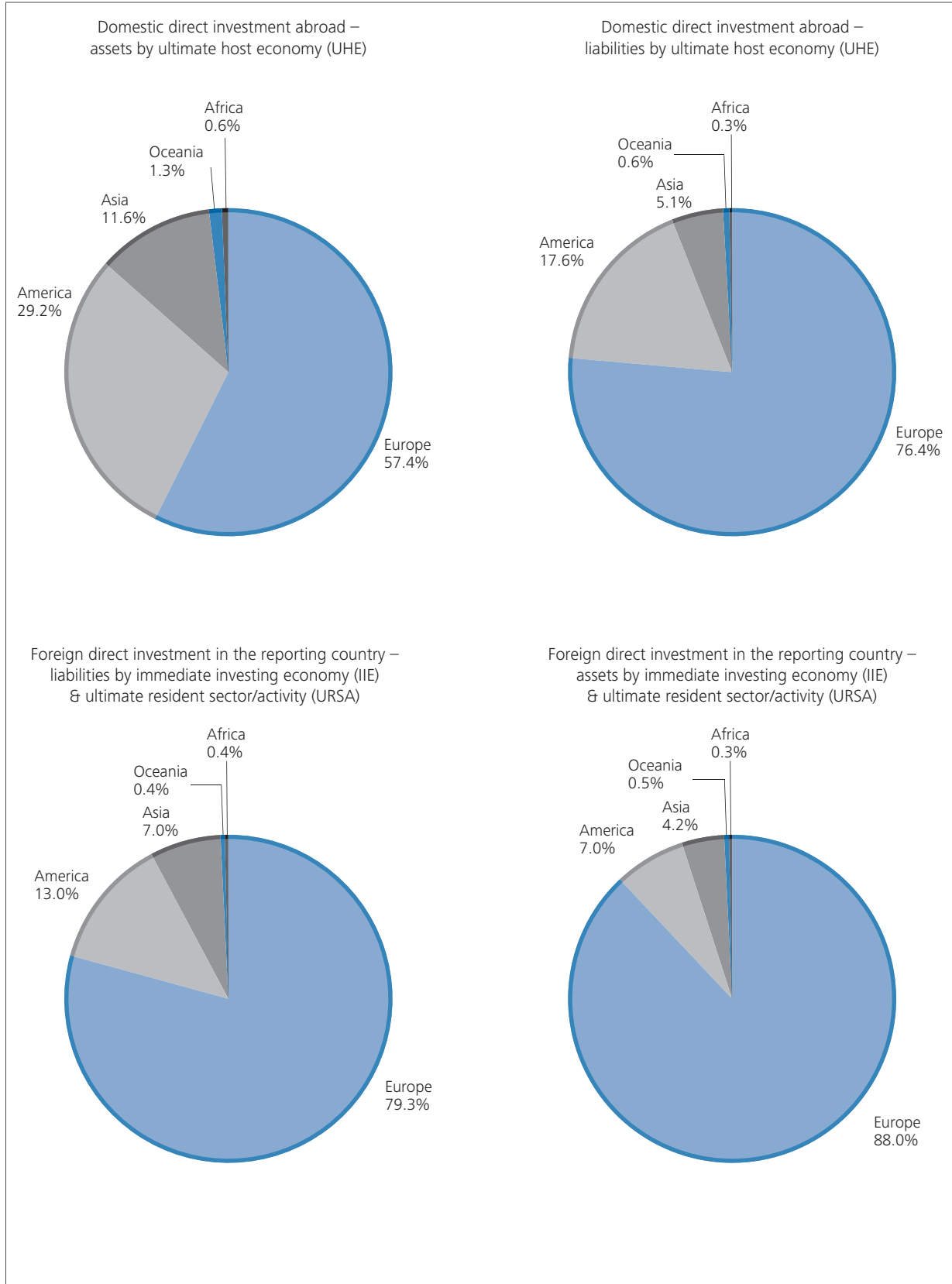
