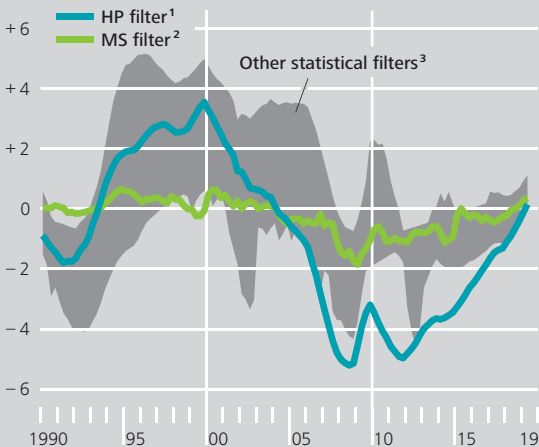


Credit-to-GDP gap for German banks' loans to households for house purchase*
