Announcement of auction Reopening 30-year Federal bond

As already announced in the issuance calendar for the first quarter of 2021, the Federal Government will reopen once again the

1.25 % bond of the Federal Republic of Germany of 2017 (2048)
issued on 20 September 2017 - ISIN DE0001102432

on 17 February 2021, using an auction procedure. An increase of € 1.5 billion is envisaged for the issue (auction allotment and retention quote). The current volume of the bond amounts to € 25.5 billion. Members of the Bund Issues Auction Group are entitled to bid.
