1 Introduction

With effect from 5 October 2025, adjustments will be made in RPS SEPA-Clearer as a result of SEPA scheme changes by the European Payments Council (EPC). Draft versions of relevant SEPA-Clearer schema files and technical specifications have already been made available on Bundesbank's website.¹

This document describes testing to be completed by <u>direct</u> participants of the RPS SEPA-Clearer in this regard.

Successful completion of mandatory test cases is a prerequisite for further participation in the SCT, SDD Core and SDD B2B service. Please inform us as soon as possible if delays in implementing the changes become apparent in your institutions.

No tests are required for indirect participants.

For <u>new participants</u>, the rules described in the procedural rules apply.

2 Participants and conditions for participation

All direct participants of the SCT, SDD Core and SDD B2B service in the RPS SEPA-Clearer must successfully complete the tests described in this document.

Participants must satisfy the following conditions to take part in the test phase:

- The necessary test infrastructure (especially hardware, software, communication channel) is available.
 - Communication via EBICS or SWIFTNet FileAct to the test environment of Deutsche Bundesbank has been set up successfully.
 - Successful conduction of own quality assurance tests by the participant.
- Registration as a test participant has already been submitted to the Bundesbank.

It is generally possible to use a technical service provider to carry out the test. Please name your service provider and contact person in the online registration form. In addition, you must also inform your service provider.

3 Test Registration

Participant must register for testing **by 27 June 2025 at the latest** via Bundesbank's website using an online registration form.

4 Test period

Testing have to be carried out in the following period:

21 July 2025 – 5 September 2025

Test cases should be carried out by each test participant within one calendar week. Please indicate your institutions desired calendar week in the online registration form.

Relevant EBICS or SWIFTNet FileAct communication must already be set up before the respective test period in order to ensure smooth testing.

5 Test execution and submission window of the test environment

In order to ensure the smooth execution and monitoring of test activities by Deutsche Bundesbank, it is necessary for each test participant to provide information on the static data used for testing in advance. This is done as part of the registration process via the online form as described in point 3.

Purpose of testing is to ensure compliance of the direct participant's setup with the specifications made in Bundesbank's procedural rules. For this, the test cases defined in Annex C are to be completed.

Please note that the test data used in testing should be anonymised data, whereby the participant is responsible for making it anonymous.



Different operating hours apply in the SEPA-Clearer test environment than in the SEPA-Clearer production environment. The following submission windows are available for testing:²
