As already announced in the issuance calendar for the third quarter of 2022, the Federal Government will reopen once again the

by auction on 12 July 2022. An increase of € 5.5 billion is envisaged for the issue (auction allotment and retention quote). The current volume amounts to € 11.5 billion. Members of the Bund Issues Auction Group are entitled to bid.
