As already announced in the issuance calendar for the third quarter of 2022, the Federal Government will reopen the

0.40 % Federal Treasury notes of 2022 (2024)
due on 13 September 2024
issued on 9 August 2022 - ISIN DE0001104891

by auction on 13 September 2022. An increase of € 5.5 billion is envisaged for the issue (auction allotment and retention quote). The current volume amounts to € 6 billion. Members of the Bund Issues Auction Group are entitled to bid.
