Auction announcement Reopening of five-year Federal notes (Bundesobligationen – “Bobl”) series 190 by auction

As already announced in the issue calendar for the third quarter of 2024, the Federal Government will reopen once again the

2.50 % five-year Federal notes series 190 of 2024 (2029)
ISIN DE000BU25034

on 27 August 2024, using an auction procedure. An increase of € 4 billion is envisaged for the issue (auction allotment and retention quote). The current volume of this series amounts to € 8 billion. Members of the Bund Issues Auction Group are entitled to bid.

Maturity: 11 October 2029
Interest payment: annually on 11 October,
interest has begun to accrue on 18 July 2024
First interest payment: 11 October 2025 for 450 days
