Auction announcement Reopening of five-year Federal notes (Bundesobligationen – “Bobl”) series 191 by auction

As already announced in the issue calendar for the first quarter of 2025, the Federal Government will reopen once again the

2.40 % five-year Federal notes series 191 of 2025 (2030)
ISIN DE000BU25042

on 25 March 2025, using an auction procedure. An increase of € 4.5 billion is envisaged for the issue (auction allotment and retention quote). The current volume of this series amounts to € 14.5 billion. Members of the Bund Issues Auction Group are entitled to bid.

Interest payment: annually on 18 April,
interest has begun to accrue on 16 January 2025
