Invitation to bid Reopening of three Federal bonds

As already announced the German Federal Government will reopen the following Federal bonds through a multi-ISIN auction on 14 January 2026:

3.25 % bond of the Federal Republic of Germany of 2010 (2042)

ISIN DE0001135432
Maturity: 4 July 2042
Current volume : € 22 billion

0 % bond of the Federal Republic of Germany of 2021 (2052)

ISIN DE0001102572
Maturity: 15 August 2052
Current volume : € 34.5 billion

2.90 % bond of the Federal Republic of Germany of 2025 (2056)

ISIN DE000BU2D012
Maturity: 15 August 2056
Current volume : € 18 billion

An increase of € 3 billion in total is envisaged for the reopening of all bonds (including respective retention quote) with a planned share of € 1 billion for the 3.25 % bond of the Federal Republic of Germany of 2010 (2042), ISIN DE0001135432, € 1 billion for the 0 % bond of the Federal Republic of Germany of 2021 (2052), ISIN DE0001102572, and € 1 billion for the 2.90 % bond of the Federal Republic of Germany of 2025 (2056), ISIN DE000BU2D012. The effective increase of each bond will be determined by the allotment on 14 January 2026.

Members of the Bund Issues Auction Group are entitled to bid. Bids must be for a par value of not less than € 1 million or an integral multiple thereof. The price bids must be expressed in terms of full 0.01 percentage points. Non-competitive bids are possible. The bids accepted by the issuer will be allotted at the price specified in the bid. Non-competitive bids are filled at the weighted average price of the competitive bids accepted. The right to scale down bids is reserved.

Time schedule of the auction procedure:

Bidding period: Wednesday, 14 January 2026,
from 8.00 a.m. until 11.30 a.m. Frankfurt time

Including in stock
exchange trading: Wednesday, 14 January 2026

Value date: Friday, 16 January 2026

In addition, the Auction rules, the Special terms and conditions of the Deutsche Bundesbank for auctions of Federal securities using the Bund Bidding System (BBS) and the issuance terms and conditions of the initial issuance shall apply.
