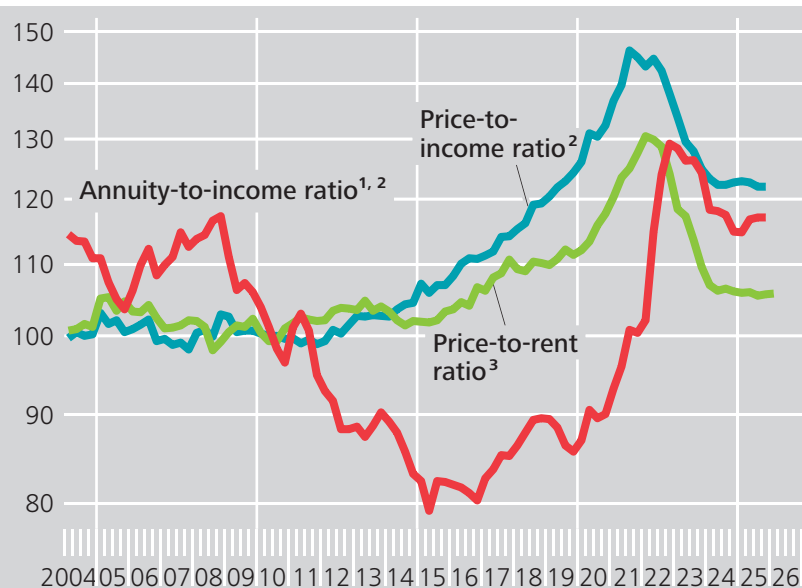


# Standard indicators to evaluate residential property prices in Germany\*
