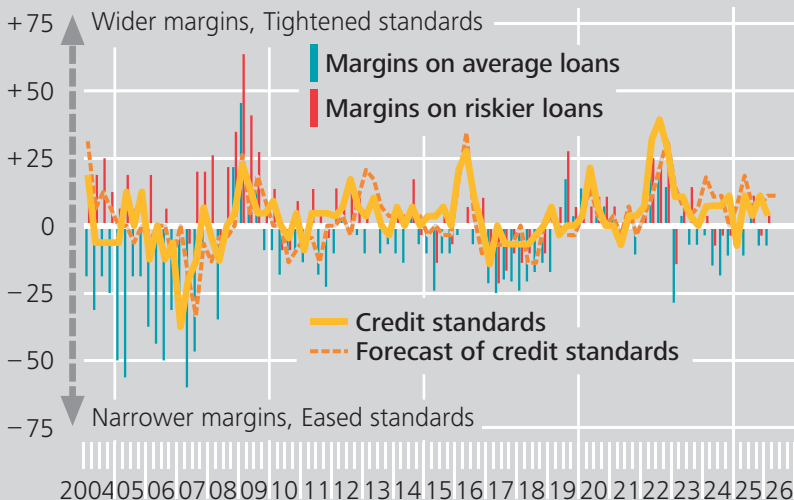


# Changes in credit standards and interest margins\* on loans to households for house purchase in Germany
